REMINDER FROM THE TAX COLLECTOR:

TAX BILLS FOR JULY AND JANUARY PAYMENTS ARE MAILED OUT AT THE END OF JUNE. IF YOU REQUIRE A RECEIPT, PLEASE MAIL BACK THE ENTIRE BILL WITH A SELF-ADDRESSED, STAMPED ENVELOPE. IF YOUR ADDRESS HAS CHANGED, SUCH AS ADDING OR REMOVING A P.O. BOX, PLEASE UPDATE THIS INFORMATION WITH THE ASSESSORS.

FROM THE TOWN CLERK:

DOG LICENSES MAY BE OBTAINED BEGINNING IN JUNE IN THE TOWN CLERK'S OFFICE. DOGS MUST HAVE A CURRENT RABIES VACCINATION IN ORDER TO BE LICENSED. SPAYED/NEUTERED DOGS: \$8.00, NON-SPAYED/NON-NEUTERED DOGS: \$19.00. A LATE FEE OF \$1.00 PER MONTH IS ADDED AFTER JUNE.
