The meeting was called to order via Zoom at 7:31p.m. by First Selectman Magi Winslow.

Motion: Magi Winslow/Scott Levan– Unanimous
To approve minutes from previous meeting(s) as presented.

To approve Expense Reports for January, 2022.
As requested by Scott Levan and Greg Sottile, Magi Winslow reported that \$432.00 was spent on FOI from our Legal Line in February, 2022. These charges were related to the Sevetz VS Board of Selectmen case.

Treasurer Karen Eseppi gave an overview of our proposed budget \$ and the process going forward to the BOF.

Update Coronavirus/Town Buildings:

Magi Winslow reported our Town Attorney rate per hour will be increasing to \$340/hr.

Scott Levan and Greg Sottile will be working together to make an adjustment on the Transfer Station/Bulky Waste Pit fees for debris coming from contractors. Currently we are losing money on fees collected.

Magi Winslow reported the DEEP is starting a program regarding testing at closed landfills. This may include an effort to require sampling and analysis for PFAS near sensitive receptors – with the responsibility and cost passed on to the land owner (Town).
