Magi Winslow announced an event to honor Wade Cole. A stone bench with plaque has been purchased by the Lions Club. The BOS has given permission for it to be placed in the West Hartland Cemetery. A dedication Ceremony will be held on Sunday, May 22, 2022, at 2pm. A small Reception is planned after the Ceremony at the West Hartland Library Building. More details will be forthcoming.

Scott Levan reported he is seeing damage to Sunset Road from the State Logging project. Scott will contact the DEEP/DOT and discuss repairs.

Peter Sevetz asked if the Town has a Tree Warden. Magi Winslow reported Wade Cole was our Tree Warden. Scott Levan is interested in being certified and taking over this responsibility. The position is not a paid position.

Peter Sevetz reported he contacted MVD and was told we are not in compliance as we have not submitted a listing of vehicles using municipal plates. Scott Levan reported he has been in discussions with MVD as we need additional plates. The Town will submit the required information to the MVD.
