SPECIAL MEETING OF THE BOARD OF SELECTMEN TUESDAY, AUGUST 16, 2022

Attending: Magi Winslow, Greg Sottile, Scott Levan, Karen Eseppi -- via Zoom

Meeting was called to order at 3:30p.m. by First Selectman Magi Winslow

Reported Information:

Our Town Mechanic, Joey Raskauskas, found a 1993 Automatic Plow truck for sale, complete with plow and sander. The truck is perfect for Town needs. The Truck will also allow us to continue our plowing/maintenance work should another truck break down while working on a project, instead of stopping and repairing that truck immediately.

Our Town Mechanic and Road Forman physically inspected the truck and found it to be mechanically sound and in excellent condition.

The Price of the Truck is \$27,500.00 (originally \$28,000.00).

We are scheduled for purchase of a new plow truck in the year 2026 of the Town 10-Year Equipment Plan. Currently the estimated cost of such a plow truck is \$325,000.00 and we anticipate the cost will increase over the next many years.

We have just purchased a new fire truck for EHVFD (\$602,000.00) and are scheduled to purchase a new fire truck for WHVFD in the next couple of years.

We are very familiar with repairs/parts on Mack trucks.

We estimate this purchased truck will last 15+ years and put us in a better position as a Town for the scheduled large equipment purchase(s) in our 10 Year Plan.

We will take the money from our Capital line #050 Camp Alice Merritt Dam Repairs, as we are not ready for the Project. We will refund the line item over the next budget years.
