MINUTES MEETING OF THE BOARD OF SELECTMEN MONDAY, JANUARY 9, 2023

The meeting was called to order (VIA Zoom) at 7:32p.m. by First Selectman Magi Winslow.

Update Coronavirus/Town Buildings:

Magi Winslow reported masking is now voluntary at all Town buildings. Currently, Boards/Commissions have the option of "in person meeting", Zoom meeting or both. There are still testing kits and masks available if needed. Sanitizer is still available in the Town Hall lobby and in the Offices at Town Hall. If you are showing symptoms of Covid or have been exposed to someone who has Covid, please do not come into the Town Buildings or attend Town events until it is safe to do so. The Board of Selectmen sincerely thanks you for your patience and your consideration. The BOS remains watchful as it relates to Town buildings/events and Covid exposures.

Covid cases are extremely high in the State of Connecticut and also in Hartland at this time. Magi Winslow reported covid cases at Town Hall over the Holidays. It was suggested that a sign be posted at the entryway that asks people entering to wear a mask if they are coughing, etc. Masks and sanitizer are still available at the entryway.

The reports from the Building Inspector and Fire Marshal for the Nellie B. West Project were discussed. A short zoom meeting will be held as soon as possible, to discuss how the items will be addressed. Magi Winslow will find a time that is workable for the Building Inspector, Fire Marshal and Architect.

To add an additional fee of \$75.00 for West Hartland Cemetery Services. This fee will be collected by our Cemetery contractor, Kentucky Blue, and returned to our Cemetery Account, so that our Account does not run short and burden our taxpayers.
