Motion: Magi Winslow/Greg Sottile - Unanimous
To approve April Meeting Minutes as presented.

A formal request came from the Zoning Board of Appeals to increase the application fee required to hold a ZBA Hearing for Residents. The current fee is \$100 which does not cover the legal notice(s) requirement in order to hold a hearing. Additionally, the State requires a \$60.00 fee for each such hearing. Hartland's ZEO was contacted as to the procedure to follow to change the fee. The proposed new fee would be \$360.00.
