- I. The Hartland Inland Wetlands Commission meeting was called to order at 7:00 pm by Chair Carol Mierzwa.
- II. Chair Carol Mierzwa confirmed all Commission members and guests noted above were present.
- III. Minutes from the April 13, 2022 meeting were reviewed. Maureen Watson made a motion to accept the minutes as presented. Chair Carol Mierzwa seconded the motion. Motion carried.
- IV. Old Business
 - A. 532 Hogback Ryan Sheehan (TD) the soil scientist on the project currently has Covid and is unable to attend the meeting. A new map was submitted. Mr. Hrica spoke to the Commission regarding a revised application and soil scientist report containing the new plan that would no longer have the berm. The Town of Hartland and State of Connecticut need to be contacted regarding the re-routing of Route 20, with the applicant believing that doing anything else at this time could make the condition worse. Statute of limitations on correcting the flooding or overflow issue to see if this can be resolved. Chair Carol Mierzwa made a motion to accept the revised application removing the berm and restoration of the wetlands. Maureen Watson seconded the motion. Motion carried. Should any Commission members have any questions for Mr. Hrica they may contact him by May 31, 2022.

A. 265 Center Street, West Hartland (MW) – Darrel & Jennifer Pecott
The original application needs to be stamped by the Town Clerk. The property is
designated as Farm and Forestry classification per Section 4 of the Wetlands
regulations. Chair Carol Mierzwa made a motion that it is determined, based on the
application, that this property is a right of use and Mr. Pecott will only need to pay
the \$60 DEEP fee. Mapping indicates forestry. Maureen Watson seconded the
motion. Motion carried.

B. 17 North Hollow Road, East Hartland (SS) – Adam Warsawik
A soil scientist has determined that drainage is good, and the owner is looking to
place their house on the peninsula of the property. It will take a few more days to flag
the wetlands and the property owner stated he will not be going into wetlands. The
Commission informed Mr. Warsawik that he needs to include actual house plans,
wetlands delineated, and FVHA letter approving the proposed septic. The property
owner withdrew his application and will re-submit it once he has the three items the
Commission requested.

- A. 265 Center Street, West Hartland (MW) Darrel & Jennifer Pecott this item was moved to New Business for the meeting
- B. Hartland Pond 25 Pinehurst Road, West Hartland There are several items that are incorrect on the application.
- C. Utilizing the Town website Chair Carol Mierzwa made a motion to begin posting agendas and minutes for the Wetlands Commission as of January 2022. Steve Stevens seconded the motion. Motion carried.

- C. Lot #8 of Groth Subdivision (CM) Paul Ringiewicz. An email was received last month about seeding and hay mulching areas of the property. The engineer for the property would like the Wetlands Enforcement Officer to be on site when trees and brush are removed from the intermittent streams. Chair Carol Mierzwa and WEO Scott Eisenlohr will walk the property with Fletcher Smith to determine best practices.
